

It is to state that during meeting of National Judicial Policy Making Committee (NJMPC) held on 09-12-2022, during discussion, some decisions were taken requiring initiation of proceedings promptly so as to comply with such decision and therefore the Hon'ble Chief Justice of this Court has been pleased to pass the following orders:-

- a. Directions may be issued to all the learned District & Sessions Judges to ensure the disposal of Old cases filed upto the year 2010 within a period of three (03) months. *(These cases are already identified and reasons whereof are already submitted by the courts.)*
- b. Directions may be issued to all the learned District & Sessions Judges to monitor the progress of submission of final challan in the cases wherein interim challan has been submitted and final challan is still awaiting.
- c. Directions may be issued to all the learned District & Sessions Judges to ensure the immediate disposal of Cases of UTPs who are confined for 05 or more years and also the cases of UTPs confined for 03 years be decided within a period of 03 months. *(List of such cases are annexed and further the Jail visit reports clearly indicate the number of such UTPs, as such these cases be identified and proceeded)*

You are therefore requested to issue directions to the concerned courts and monitor the progress of such cases for each date to ensure compliance of the above orders.
