Subject: **REQUEST FOR ISSUING DIRECTION TO TRIAL COURTS FOR PROVIDING COPY OF JUDGMENTS FOR MONITORING CONVICTION AND ACQUITTAL RATES & ACCOUNTABILITY OF INVESTIGATION OF OFFICER**

In pursuance of Minutes of Meeting held on 26th December 2020 & 5th December, 2020, regarding monitoring of ATC Cases in pursuance of the guidelines issued by the Hon'able Supreme Court of Pakistan in the case of Sh. Liaquat Hussain.

In order to accountability of investigating officers of Karachi Range, office of the undersigned collects the judgment in all criminal cases, award suitable rewards who succeed to convict the accused and punish to those who conduct defective investigation so also apprise to all police officer regarding flaws / left by them during trial and investigation and maintenance of record. However some Hon'ble Judges are reluctant to provide the copy of judgments. This refusal discourages this office to carry out accountability of investigation officers and maintenance of record.

It is, therefore, requested that direction may kindly be issued to all presiding officers of Hon'ble Trial Courts having criminal jurisdiction (District Courts, ATC Court, Special Courts) for provision of copies of judgment through representative of this office so that the guidelines issued by the Hon'ble Supreme Court of Pakistan and directions issued in the aforesaid meeting may be complied with in letter and spirit..
