**SUBJECT: MINUTES OF 54<sup>th</sup> NJPMC MEETING HELD ON 18.08.2025**

With reference to the subject noted above, I am enclosing herewith the minutes of 54<sup>th</sup> NJPMC meeting held on 18.08.2025, which were placed before the Hon'ble Chief Justice and after perusal following directions were issued.

Decisions of NJPMC	Direction of Hon'ble Chief Justice
<b><u>Additional Agenda # 2 (Model Civil Courts)</u></b>  The Forum, while appreciating the efforts made by the Lahore High Court, decided that the High Courts may pilot the initiative for oldest civil cases in chronological order. The High Courts may determine the number of Model Civil Courts in each district keeping in view the number of target cases. The District and Session Judges may assign such case to Model Civil Courts under a time bound trial regime.	In view of the decision of NJPMC, the details of pendency of civil cases in District Courts is submitted at <b>Flag "C"</b> .  Looking into the pendency of Civil cases, and in the first instance one Court of Senior Civil Judge in each District of Karachi Division, District Hyderabad, Sukkur, Mirpurkhas, Shaheed Benazirabad, Khairpur, Ghotki, Shikarpur and Nausharo Feroze with the consultation of concerned District & Sessions Judge may be nominated as "Model Civil Court" for the expeditious disposal of the oldest Civil Cases. Upon nomination of a Model Civil Court, the learned District & Sessions Judge concerned shall assign thereto the oldest pending civil cases, strictly in chronological order. The Model Civil Court, upon receipt of such cases, shall ensure their disposal within a period not exceeding six months. It is further respectfully proposed that the decision of NJPMC regarding establishment of Model Civil Court may be communicated to Senior Faculty Member, Sindh Judicial Academy to draft a comprehensive "Action document" for the guidelines of Model Civil Courts (MCCs) in replicate of "Action Document" of previously established Model Courts like MCTCs, MCACs & MTMCs.

You are, therefore, required to ensure compliance of above directions of Hon'ble Chief Justice in letter and spirit under intimation to this office.
