In response, the Honourable Court had called the then District SSP vide letter No. A/W/ 2459, dated 17-07-2023, on Tuesday i.e. 18-07-2023 at 02:30 pm. Copy is attached as Annexure 'B'.

Later on, the Honourable Court vide letter No. A/W/ 3705, dated 17-10-2023, called proper list of cases Court wise regarding the Proclaimed Offenders & Absconders. Copy is attached as Annexure 'C'.

Subsequently, on 18-10-2023, proper list of cases Court wise regarding the 544 Proclaimed Offenders & 772 Absconders (Total 1316) of police stations, District Keamari, Karachi, was submitted at Office of the District & Sessions Judge, Karachi West, vide this office letter No. SSP/DK/RDR/ 906, dated 18-10-2023. This has caused a significant hindrance to the process of apprehending these individuals and bringing them to justice. Break-up / Summary of all POs & Absconders category wise is shown as under.

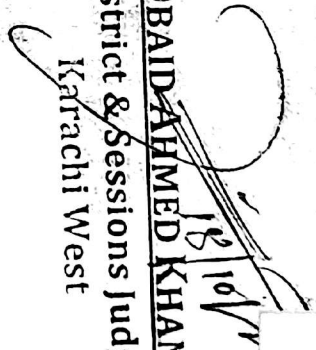
