All the Presiding Officers of this District are directed not to allow summer vacation to any official, as different nature letters are being received from Honorable High Court of Sindh, for compliance.


All urgent matters will be filed in the concerned courts and placed before the concerned Judges or vacation Judges for necessary orders and disposal.
