
SUBJECT: INCOMPLETE ENTRIES AND NON UPDATION OF CASES, DIARIES, ADVOCATES, PARTIES JUDGEMENT/ORDERS IN CFMS-DC.

It is to inform that it has been observed that staff members are not properly updating the subject details on CFMS-DC. A report to such effect has been generated indicating that Cases, Case Diaries, Advocates, Parties Judgments/Orders are either incomplete or the same are not updated on CFMS-DC. Statement indicating the number of such cases is attached herewith for ready reference.

2. It has also been observed that at the time of disposal of a case on CFMS-DC, complete details of disposal are not entered including disposal type and method which field usually is being entered as "NIL" or in some cases the relevant details are left blank. Likewise in some cases the judgment/order has not been completely uploaded. Furthermore the details of accused persons such as age, CNIC No. and other related details have not been correctly entered.

3. You are therefore requested to direct all learned Judges and issue appropriate directions so as to ensure updation of correct details in the relevant cases detailed in annexed statement within 07 days positively and further they may also be directed to ensure that all details are completely entered and updated in future within time frame.

Compliance report to such effect may be shared within 10 days period.
