Subject: **PAYMENT OF FORENSIC ANALYSIS FEE THROUGH BANK DRAFT/PAY ORDER W.E.F. 01.01.2023.**

I am directed to refer to the subject cited above and to state that Punjab Forensic Science Agency, Lahore has been collecting Private test fee from Banks, others Financial Institutions, Courts, NAB, Anti-Narcotics Force and other Provincial Government Departments on 32-A challan form since January 2021. Collecting fees through 32-A Challan form is very difficult procedure because 32-A challan form amount is not reconcilable with Accountant General Punjab due to the late submission of 32-A challan in PFSA.

2. The amount of 32-A challan form which is deposited under Object Head co2691 Forensic Laboratory fee in other provinces is not transferred to Punjab, it means actually test fee is not paid to PFSA. Due to this reason PFSA private test fee figures and Accountant General Figures are not reconciled. Furthermore 32-A challan form are not as reliable/authentic as compare to demand draft/ pay order.

In view of the difficulties stated above, Punjab Forensic Science Agency has decided to change the mode of payment of forensic analysis fee from **32-A Challan Form** to **Pay Order / Demand Draft** with title "**Director General Punjab Forensic Science Agency Lahore**" w.e.f. **01.01.2023**, and forensic analysis fee deposited through 32-A challan form will not be entertained after **31.12.2022**.

3. It is, therefore, requested to circulate the above-mentioned information to all concerned formations under your control for future compliance.
