Dear Sir,

With reference to the subject, I am directed to refer Chapter-D titled "Expeditious disposal of cases" Sub-chapter-I titled "Criminal cases" clause 14 Sub-clause (i) of the National Judicial Policy-2009 reproduced below;

14

(i) **False and frivolous litigation in civil as well as in criminal sides be discouraged by imposing heavy costs, compensation and penalties in accordance with the provisions of section 35-A C.P.C and 250 Cr.P.C so that the precious time of the Courts may not be wasted and utilized for redressal of genuine grievances of the litigants.**

2. The aforementioned Policy direction provides for **compensatory cost in respect of false or vexatious claims or defences** in terms of section 35-A of the Code of Civil Procedure 1908 and compensation on account of false, frivolous or vexations accusations under section 250 of the Code of Criminal Procedure 1896.

3. The imposition of costs would not only be beneficial in deterring the person who approaches the court with ulterior motives and misuse the process of law but also it would be beneficial in providing speedy and expeditious justice to the deserving.

4. It is, therefore, requested that the requisite information on attached format **(Annexure-A and B)** for the period from 1.1.2022 to 31.12.2022 may be provided to this Secretariat by **5th of January 2023** for submission before the NJPMC.
