Subject: **GRANT OF LEAVES TO JUDICIAL OFFICERS**

I am directed to enclose herewith copies of letters dated 06.03.1997 and 03.03.1998 (copies enclosed) inviting your attention on the instructions contained therein and further to state that it has been noticed that Judicial Officers avail casual leaves frequently thereby consuming their limit of such leave before close of casual leave year and thereafter for short periods the applications are being received for grant of earned leave. Such practice is in violation of the earlier directions contained in the above mentioned letters. It may be clarified that casual leave limit provided for a judicial officer does not imply that complete account of leave has to be consumed but it is only leave account maintained for meeting the urgent casual nature of work.

It may be considered that such leave affects already scheduled Court work resulting in return of witnesses and adjournment of cases which impairs smooth proceeding of cases and thus allows the backlog of cases to increase multifold.

All the learned District & Sessions Judges are therefore requested to ensure that leave application(s) including earned leaves should be considered and/or recommended only when there are cogent reasons mentioned therein.

Subject:- GRANT OF CASUAL LEAVE TO THE JUDICIAL  
OFFICERS IN SINDH.

I am directed to say that the Hon'ble Chief Justice has noticed that the Judicial Officers mostly consume their quota of casual leave before the expiry of casual leave year and thereafter they request for grant of earned leave for a day or two for casual purposes. The Hon'ble Chief Justice has taken exception to it and has ordered that the officers should be cautious enough in availing of casual leave and must not avail it so frequently as to consume full quota before expiry of the casual leave year. In case their applications for earned leave are received for short periods and casual purpose the same will be rejected unless accompanied with convincing reasons and the officer will be treated as absent from duty.

These instructions may be brought to the notice of all the Judicial Officers working under you, for future guidance and compliance.
