to amend the Sindh Civil Courts Ordinance, 1962.

WHEREAS it is expedient to amend the Sindh Civil Courts Ordinance, 1962, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Civil Courts (Amendment) Act, 2021.

- (2) It shall come into force at once.
2. In the Sindh Civil Courts Ordinance, 1962, hereinafter referred to as the said Ordinance, in section 7 -
- (a) for the words "fifteen million", the words "sixty five million" shall be substituted; and
- (b) in the proviso, for the figures "2010" the figures "2021" shall be substituted.
3. In the said Ordinance, in section 24, for the words "fifteen million" wherever occurring, the words "sixty five million" shall be substituted.
