Subject: **EXPEDITIOUS DISPOSAL OF CASES AS PER THE DIRECTIONS OF NJPMC.**

Respected Sir/Madam,

With reference to the subject cited above and in consequent to the meeting of National Judicial Policy Making Committee (NJMPC) held on 30-03-2022, the Hon'ble Chief Justice of this Court has been pleased to pass the following orders:-

"CRIMINAL CASES"

- a. All pending criminal bail applications/Special Bail Application/cancellation of bails/Bail application in cases filed up to 31-03-2022, be decided within 15 days period positively and it be ensured that arrears of such categories filed before 15th of each month should not be taken to next month as the same be disposed of.
- b. Criminal appeals/Criminal Revision filed up to December 2021, be decided within a period of 30 days positively.
- c. All Criminal Misc. Application, Criminal Misc. Applications in Sessions cases and Criminal Transfer Application filed up to February 2022, be decided within a period of 15 days positively.
- d. All Criminal Petitions/Criminal Petitions under section 22-A Cr.PC and Habeas Corpus applications/applications u/s 491 Cr.PC filed up to 28-02-2022, be decided within a period of 15 days positively. It be also ensured that pendency of these petitions/applications should not be carried forward to next month unless the same are filed in the last week of the month.


- e. All criminal cases involving the punishment up to 7 years filed till year 2020 be decided within a period of 2 months.

“CIVIL MATTERS”

- f. All Civil Appeals filed up to 31-12-2020, Civil Miscellaneous and Civil Revisions filed up to December 2021, be disposed of within a period of 60 days.
- g. All Civil Transfer Applications filed 28-02-2022, be decided within a period of 15 days.
- h. All Civil Misc. Applications filed up to 28-02-2022, be decided in 15 days.
- i. All Civil Executions, Family Executions, G&W Executions, Rent Executions and Summary Executions filed up to 30-06-2021, be decided within 45 days.
- j. All Family Appeals filed up to 31-12-2021, be decided within 30 days.
- k. All Family Suits filed up to the year 2020, be decided within a period of 2 months.
- l. All S.M.As filed up to 31-01-2022, be decided within a period of 30 days and it be ensured that such non-contentious matters should be decided within a period of 30 days so that the pendency of such cases is not taken forward to next month.
- m. All Civil Suits filed up to year 2015, be decided within a period of three months positively.

This office has prepared a chart reflecting number of pending cases in each category mentioned above, the list of such cases is also attached herewith which may be sent individually to concerned courts for compliance. Further the cut of date in each category is mentioned in the proforma and the progress reports of such cases may be sent to this office within 03 days after the expiry of cut of date.

You are, therefore, requested to ensure compliance of the above said directions in letter and spirit.
